Therefore, I assume full responsibility for using the play equipment located at **JUMPER'S JUNGLE FAMILY FUN CENTER** and I voluntarily and freely choose to assume all such risks and dangers, including the risk of injury or fatality that may be associated with, or result from, using the play equipment, and will not claim negligence of **JUMPER'S JUNGLE FAMILY FUN CENTER**, its staff or other guests.

I, for myself, my heirs, personal representatives or assigns, shall agree to defend, indemnify, and hold harmless R3D Entertainment LLC dba **JUMPER'S JUNGLE FAMILY FUN CENTER** and any of their agents affiliates, officers, members, employees, and other guests from liability from any and all claims, lawsuits, and demands for any damages resulting in personal injury, accidents, illnesses, fatality, monetary loss, or property damage.
